Stand set-up and dismantling times

Stand set-up:

Friday, 21 January 2022, 7.00 to 20.00

Saturday, 22 January 2022, 7.00 to 10.00

Stand dismantling:

Saturday 22 January 2022, 19.00 to 24.00

Outside these times stand set-up and dismantling require prior approval of Messe Stuttgart. Due to reasons of safety, the presence of all persons who are not directly involved in compulsorily insurable work, **especially minors**, shall be prohibited during stand set-up and dismantling work in the halls as well as in the outdoor exhibition area.

The hall may not be driven by vehicles!

The dismantling of the stands may only be started after the exhibition has ended.

Rental charges

THERMIK-Exhibition area

The minimum size of a stand space is 9 m²

Smaller areas are only rented if they result from the planning.

Stand space for one fair day **39,00 € per m²**

Eco-fee (Messe Stuttgart) **4,00 € per m²**

Exhibition space in the foyer on request.

Partition walls: 2,50 m high **21,20 € per m**

The stand is limited by partition walls (side and rear walls). These are compulsory, even with own stand construction, and are rented by the organizer. The costs of the partition walls are not included in the stand space rental and are based on the stand size (depth and width of the stand area). It should be noted that every three or four linear meters of partition wall must be supported.

For large block stands, no partition walls are necessary.

Carpet: red, blue, green or grey **5,80 pro m²**

There is no carpet required, the hall has a parquet floor

Power connection (3 kW/230V) **156,00 €** incl. power consumption

AUMA fee is waived

Media fee is waived

Term parking permit**

Parking garage: **17,00 €/day** (for vehicles up to 2 m high, not suitable for trailers)

Exhibitor parking with trailer: **34,00 €/day**

Truck pool (up to 9 m): **60,00 €/day**

** plus € 2,10 (+ VAT) handling fee per order transaction

VIP parking permits at the hall front

and further designated VIP parking

for cars / vans without trailer (up to 5.00 m in length) **56.00 €/day**

Entrance Control

When approaching the fair ground, follow the signposting „delivery“.

The access to the trade fairgrounds is via **gate 2**.

The length of stay in the trade fairgrounds for unloading and loading is limited in time. A deposit of **100 €** will be charged for compliance. The deposit must be **paid in cash** before entering the fair grounds at the check-in and will be returned if you leave in time at **gate 1** again. You will forfeit the deposit if you do not leave on time. An extension of the deposit time can be made by the service staff on site.

The length of stay for vehicles on the exhibition grounds during set-up and dismantling is:

Cars: 1 hour

Cars with trailer / (small) vans: 2 hours

Trucks: 3 hours

During the trade fair period on Saturday, all vehicles have a residence time of 0.5 hours.

On Saturday, there is no access for vehicles to the fair trade ground from 12.00 noon after the end of the event (19.00).

Suspension points

The points can be ordered via the service partner Neumann & Müller (messe.stuttgart@neumannmueller.com).

The exhibitor will receive an O-ring at a height of 8 m as the transfer point. Below a transfer height of 8 m, an additional drop per suspension point is required. (Prices as of 2/2019, change possible)

165,00 € not for use with hoist

for use with hoist on request

29,50 € for drop

The above prices for the suspension points are understood without mounting the exhibits on the O-ring. Please ask for a detailed offer about the service partner Neumann & Müller.

The max. Load is 100 kg per point.

The order must be accompanied by plans showing the desired placement of the suspensions points, including the height specification. Basically, no suspensions of objects that are connected to the ground are allowed. The minimum distance for suspensions to standing on the ground objects, or stand constructions is 50 cm in height.

Suspensions may only be located above their own level and not in public areas, e.g. passages or overhang the neighbour's stand.

Suspensions of all kinds are part of the stand construction and result in the maximum standing height of 3.50 m being exceeded. They require the approval of the Technical Service Department.

Exhibitor passes / Work passes

Each exhibitor receives no charge for the stand size

to 06 m² 2 exhibitor passes + set-up and dismantling passes

from 07 to 09 m² 3 exhibitor passes + set-up and dismantling passes

from 10 to 49 m² 4 exhibitor passes + set-up and dismantling passes

from 50 to 89 m² 8 exhibitor passes + set-up and dismantling passes


from 90 to 129 m² 12 exhibitor passes + set-up and dismantling passes

If additional passes are required by the exhibitor for the day of the fair, these are chargeable **17,00 €**.

Additional passes can be ordered by mail (info@thermikmesse.de) via the THERMIK team.

Additional passes for setup and dismantling are free of charge.

Insofar as the exhibitor does not serve his own employees for stand construction, the exhibitor is obliged to apply for the dismantling and dismantling passes for the persons employed for this purpose and to forward them to himself.





Co-exhibitor / additionally represented companies

The acceptance of a co-exhibitor and additionally represented companies must be requested using the registration form.

For co-exhibitors (**companies that have their own staff and their own offer at the stand of a main exhibitor**) a registration fee of **65.00 €** must be paid.

For additionally represented companies (**companies whose goods and services are offered without their own personnel by the main exhibitor**), there is usually no fee.

Specifications for the stand construction

It is a structural demarcation of the floor space to the neighbouring stands prescribed. If no own stand construction system is used or rented via the THERMIK team, opaque, 2.5 m high partition walls (rear and side walls) are mandatory. Stand backs should be kept neutral and completely closed. Roll-ups and poster displays are not permitted as stand limits.

The stand construction must be made transparent to all aisle boundaries. Maximum 30% of an open page may be built with partitions or other closed systems.

It is expressly pointed out that, depending on the wall system, every three or four linear meters of partition wall must have a supporting wall.

Hygiene measures at the trade fair/exhibition stand

The exhibitor is responsible for implementing and conscientiously complying with the protective and hygiene regulations applicable at the trade fair stand at the time of the event. These requirements apply in addition to the Technical Guidelines of Messe Stuttgart. Stand equipment

The rented area does not have to be equipped with a floor covering.

Transparent, advertising, company signs, etc. may not protrude into the corridors or be placed outside the standing height.

For the construction, only hardly inflammable materials acc. DIN 4102 B1 can be used. Easily inflammable or burning dripping materials or polystyrene hard foam (styrofoam) or similar materials are prohibited.

Decoration fabrics must be flamm-retardant. The use of straw, hay, bamboo, peat, bark mulch, bundles of natural deciduous and coniferous branches and the like is prohibited. Trees and plants may only be used in the green state.

Self-adhesive carpet tiles are not allowed. Carpets may only be fastened with double-sided adhesive tape, which can be removed without residue. Carpets and floor coverings are to be laid accident-proof. The attachment of bolts and anchors of any kind in the floor is not allowed.

The nailing, pasting and painting of walls, floors and furnishings (especially of partition walls) is not permitted. Partition walls may only be burden with a weight designed for this purpose.

Exhibits, equipment and installations must be located within their own stand space and must not affect the neighbouring stand. Standing pillars, installation and fire protection equipment are part of the stand space.

If the exhibitor does not start stand set-up on the day of the trade fair at 9:00 am, the place may be used elsewhere without the exhibitor's obligation to pay the stand rental being cancelled.

The sound of the stand is subject to approval. The sound is to be chosen so that surrounding stands are not affected. Repeated complaints by other exhibitors may lead to the prohibition of the operation of the sound system.

Presentations, raffles of all kinds are subject to approval. The performance must take place on your own stand.

The distribution of flyers outside the own stand is not allowed.

Hall lighting

The hall is equipped with general lighting. For stand and product presentation the installation of spotlights is recommended.

Sale / Distribution of samples

With regard to the sale of exhibition pieces, the exhibitor is obligated to display the item in question with clearly legible price label and to comply with the regulations regarding price labelling. The acquisition of and compliance with trade and health commission authorization is solely the responsibility of the exhibitor.

Disposal

The exhibitor is responsible for the cleaning and waste disposal of his stand.

It is not permitted to store waste in the aisles during the construction and dismantling periods.

Any waste left in the aisles will be disposed of by contractors at increased cost.



List of Exhibitors

The media fee is waived. Thus, there is no entry in the exhibition catalogue of the CMT. All exhibitors will be listed exclusively on the homepage of the THERMIK fair www.thermikmesse.de with logo and address.

It is expressly pointed out that no third parties, including other publishers, are commissioned or commissioned with the preparation of trade fair publications and exhibitor directories. Insofar as offers in this respect should go to the exhibitors, these are own initiatives of third parties, which have no relation to the THERMIK fair.

Cancellation charges

Cancellations of stand construction / services take place solely according to point A 6 of the General Terms and Conditions for Services of Landesmesse Stuttgart GmbH. Cancellations with regard to the rental of space take place solely in accordance with point 4 of the General Exhibiting Conditions.

Terms of payment

Payments are due until 31.12.2021 after receipt of invoice, unless otherwise stated in the invoice.

Payments are to be made without any deductions to a bank account printed on the invoice. Check payments are not allowed.

Until the rental fee has been paid in full, the exhibitor shall neither receive IDs allowing admission nor a stand set-up pass and permission to build the stand.

Invoices for special services of Landesmesse Stuttgart and its contractors are due for payment upon receipt of the invoice.

If payment is made after the due date or in other cases of delayed payment, our claims shall be determined in accordance with § 288 German Civil Code (BGB).

All our prices (incl. stand rentals) are net. The indicated statutory VAT valid at this time (according to the relevant version of the Value Added Tax Act) has to be added and paid.

If the recipient of performance (exhibitor) is not based in Germany, the tax liability can be shifted to the recipient (reverse-charge), provided that the entrepreneurship is declared in the application form. Recipients of performance from EU member states must also supply their VAT identification number.

Exhibition demolition

If an exhibition already underway is wholly or partially cancelled or interrupted due to reasons outside the control of Landesmesse Stuttgart, withdrawal from the contract or enforcement of compensation claims shall be excluded.

Insurance

To avoid liabilities, especially for damages we strongly recommend to take out an insurance or using the form insurance in the service catalogue of Landesmesse Stuttgart.

Eco surcharge

The eco surcharge per square meter exhibition area (hall and outdoor area) is 4,00 € net and will be charged to the exhibitor's account. Further information regarding the eco surcharge can be found at www.messe-stuttgart.de/agb.
